- 3- Performing the works approved by the executive committee and general body of the organization and taking care of the organization.
- 4- Protecting the movable and immovable property of the organization, receiving donations, grants, donations and membership fees and signing all documents, loans, grant checks, mortgage bills and bill bauchers.
- 5- To advocate all types of court proceedings on behalf of the institution and keep all the records safe with you.
- 6- Appointment, removal, promotion, and dismissal of employees and workers working in institutions / institutions operating under the institution and making rules regarding their conditions of service, fixing and paying salary allowances.

4. Deputy Manager / Deputy Secretary: In the absence of the manager / secretary of the institution, to do the work assigned by him and to cooperate in the work in the presence.
